## **Recommended action**

We uphold both, our ST market relative Neutral rating and LT fundamental Buy recommendation for the Company. In our view, 1Q22 financial results should be good, albeit laden with negative FX differences impact. We forecast a 40%/ 11% yoy growth of revenues/ EBITDA with almost flat yoy 1Q22 NI.

# 1Q22 financial results preview

We forecast 1Q22 revenues at PLN 229 million (up 40% yoy) assuming a 20% organic growth and expect Termet and Tester to add PLN 33 million due to a longer period (by 2 months) of their consolidation (which started in March last year).

We expect the EBIT profitability dip to 11.1% from 14.5% a year ago. We assume a materials and sales growth and forecast net financial costs at PLN 4 million vs PLN 2 million a year before. We expect PLN 17 million of NI (flat yoy).

# **FY22 financial forecasts**

We modify our expectations and raise FY22 sales/ EBITDA/ EBIT/ NI forecasts by 11%/ 12%/ 17%/ 18%. We adjust our financial forecasts for the following years accordingly. It looks like the demand for the Company's goods and products in the region stays high, with Termet and Tester doing well. Ferro is able to raise product prices shifting a cost growth to their clients. Freight costs have started to slightly fall and even though the Company's contracts are long-term, this shows some trends emerging. Ferro reshapes its assortment encompassing new products.

## **Valuation**

After the financial forecast update, a revision of (i) the risk free rate and risk market premium (from 4% to 6%), (ii) residual growth (from 1% to 2%), (iii) unlevered Beta (from 1.2 to 1.1) and peer valuation update, our 12M EFV representing a mix of the DCF valuation (50%) and peer relative valuation (50%) declines by 6% to PLN 37.1 (from PLN 39.6) per share. The DCF/peer-relative valuation yields PLN 44/30 per share (previously 46/ PLN 33 per share).

## **Strategy**

The Company aims to update its strategy in 2H22. The Company's current strategy includes (i) consolidated revenues and EBITDA targets at PLN 700 million and PLN 90 million, respectively in 2023, (ii) investment expenditures in this period below PLN 10 million till 2023, and (iii) the Group's ND/EBITDA multiple below 2.5x in 2018-23. These assumptions do not cover acquisition plans. We expect an upgrade of previous targets and announcement of new acquisitions. The Company

did not spend more than PLN 20 million on capex last year while this year capex will be significantly higher (exceeding PLN 30 million). Opening of a logistics center, in Romania, is planned for 1Q23. The implementation of ERP system is planned accompanied by the employment of necessary staff.

In 2021, 47%/ 30%/ 20% of the Company's consolidated sales stemmed from batteries and accessories/ installation fittings/ heating systems (Termet & Tester); 46%/ 18%/ 16%/ 6%/ 4%/ 10% of revenues were generated in Poland/ Romania/ Czechia/ Slovakia/ Hungary/ other countries. Exports of the heating systems segment is much lower than of other segments (<10%). The acquisition of Termet &Tester more than doubled the Group's domestic sales. The Group's organic growth in 2021 reached 27%, including a 21%/ 34% increase in sanitary fittings (sales at PLN 391 million)/ installation fittings (sales at PLN 253 million). The acquired companies consolidated from the beginning of March last year boosted the Group's revenues by PLN 169 million.

Demand for the Company's goods and products is driven by the development of the residential market in the region. In the installation fittings segment, the replacement demand constitutes 55% with 45% coming from new investments. In the section of batteries and accessories, 80% of demand results from renovations and 20% from new residential investments. The Company distributes its goods and products through traditional (66%) and modern (34%) channels. The Company benefits from a one-to-two year shift in demand with respect to the construction of apartments. Besides, the renovation and product life cycles are shortened.



In the heating segment, the top line is supported by numerous national and EU programs in the field of thermo-modernization (PLN 100 billion). According to estimates, over 4 million boilers in Poland need to be replaced. Due to small exports at Termet and relatively high at Ferro, we see a significant potential in exports development at the former.

The housing markets in Poland and neighboring countries have been faring well though there are symptoms of slowdown visible. According to Poland's Central Statistical Office,

- in 2020 (i) 224,000 dwellings were started, down 6% yoy, (ii) 222,000 dwellings were delivered, up 7% yoy, and (iii) 276,000 building permits were issued, up 3% yoy;
- in 2021 (i) 227,000 dwellings were started, up 24% yoy, (ii) 235,000 dwellings were delivered, up 6% yoy, and (iii) 341,000 building permits were issued, up 23% yoy.,

in January-February this year (i) 30,000 dwellings were started, down 12% yoy, (ii) 34,000 dwellings were delivered, down 0.1% yoy, and (iii) 48,000 building permits were issued, down 6% yoy.

According to the Czech Statistical Office,

- in 2021 (i) 45,000 dwellings were started, up 28% yoy, (ii) 35,000 dwellings were delivered, up 28% yoy, and (iii) 91,000 building permits were issued, up 6% yoy,
- in January- February this year (i) 7,000 dwellings were started, up 20% yoy, (ii) 6,000 dwellings were delivered, up 20% yoy, and (iii) 14,000 building permits were issued, up 12% yoy.

According to CEIC DATA, in 2021, in Romania 113,000 building permits were issued, up c. 12% yoy and in January-February this year 13,000 building permits were issued, down c. 6% yoy.

DM BOS S.A. generally values the covered non bank companies via two methods: comparative method and DCF method (discounted cash flows). The weakness of the comparative method is the risk that the valuation benchmark may be mispriced. The advantage of the DCF method is its independence from the current market valuation of the comparable companies. The weakness of this method is this high sensitivity to undertaken assumptions, especially those related to the residual value calculation. Please note that we also resort to other valuation techniques (e.g. NAV-, DDM- or SOTP-based), should it prove appropriate in a given case.

related to the residual value calculation. Assumptions used in valuation can change, influencing thereby the level of the valuation. Among the most important assumptions are: GDP growth, forecasted level of inflation, changes in interest rates and currency prices, employment level and change in wages, demand on the analysed company products, raw material prices, competition, standing of the main customers and suppliers, legislation changes, etc. Changes in the environment of the analysed company are monitored by analysts involved in the preparation of the recommendation, estimated, incorporated in valuation and published in the recommendation whenever needed.

#### **KEY TO INVESTMENT RANKINGS**

This is a guide to expected price performance in absolute terms over the next 12 months:

Buy - fundamentally undervalued (upside to 12M EFV in excess of the cost of equity) + catalysts which should close the valuation gap identified;

The recommendation tracker presents the performance of DM BOŚ S.A.'s recommendations. A recommendation expires on the day it is altered or on the day 12 months after its issuance, whichever comes first.

Relative performance compares the rate of return on a given recommended stock in the period of the recommendation's validity (i.e. from the date of issuance to the date of alteration or – in case of maintained recommendations – from the date of issuance to the current date) in a relation to the rate of return on the benchmark in this time period. The WIG index constitutes the benchmark.
