Event: Sales and gross profit margin for November revealed.

Yesterday, during the WSE trading hours, Action released preliminary sales and gross profit margin on sales for November. The Group's consolidated revenues reached PLN 254 million (up 8% yoy) and the gross profit margin on sales in November arrived at 7.7% (+0.1 mom/ -0.1 pp yoy).

For January-November cumulatively, Action's revenues stand at PLN 2,271 million (up 6% yoy) with the weighted average gross margin on sales at 7.9% (+0.4 pp yoy).

**Expected impact:** Neutral. Still, we cannot preclude that finally the reported margin proves to be higher than the preliminary one, as it was in the previous quarters.
