Event: Sales and gross profit margin for April revealed.

On Tuesday, during the WSE trading hours, Action released preliminary sales and gross profit margin on sales for April. The Group's consolidated **revenues** reached **PLN 180 million** (down 2% yoy) and the **gross profit margin on sales** in April arrived at **8.2%** (0.0 mom/ +0.2 pp yoy).

For **January-April** cumulatively, Action's revenues stand at **PLN 793 million** (up 2% yoy) with the weighted average gross margin on sales at **7.9%** (+0.2 pp yoy).

Expected impact: Neutral; we cannot preclude that the reported margin proves to be higher than the preliminary one, as it was in the previous quarters.
