Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type: Exchange Traded Commodities – Asset Backed Notes

Objectives: The ETC securities provide you with exposure to silver, with a foreign exchange (FX) hedge to the Euro, without requiring you to possess silver in the physical form. Each ETC security relates to a specific amount of silver, known as the metal entitlement per ETC security. The issuer (we) will seek to hold a sufficient amount of silver to cover its obligations under the ETC securities. On redemption, the metal agent JPMorgan Chase Bank N.A.) will sell the silver and proceeds will be used to pay amounts due to you. The metal entitlement is reduced on a daily basis to reflect (i) the base fee; and (ii) the FX hedging fee percentage (together the fees). The level of the fees is specified on www.etc.dws.com. The FX hedging fee percentage reflects a fee for the provision of the FX hedging element which attempts to reduce the difference between the currency in which the ETC securities are denominated (Euro) and the currency in which the silver is denominated (USD). Any gains or losses on the FX hedge will also be taken into account in the metal entitlement and will also affect the value of the ETC security. The ETC securities are not principal protected and you may lose some or all of your investment. Subject to any amounts paid to you due to early redemption, no amounts are payable under the ETC security prior to the maturity date. On redemption, it is intended that the ETC security will become payable at an amount equal to the higher of (i) 10 percent of the issue price of the ETC security and (ii) the weighted average prices at which the silver can be sold by the metal agent over a specified period prior to the redemption date multiplied by the metal entitlement on such redemption date. However, since the ability to make such payment is dependent on whether there are sufficient assets available, security holders may receive no payment or less than 10 percent of the issue price in certain circumstances. Although the ETC securities will not pay periodic interest, on redemption an interest amount may be added or subtracted, as applicable from the redemption amount in respect of interest that has accrued on proceeds of realisation of the metal (which may be zero or negative as well as positive). You may choose to sell your ETC securities prior to their maturity in accordance with your investment objectives. You should be aware that the ETC securities entitle you to receive a payment calculated by reference to the value of silver and currency movements which may fluctuate over time. The value per ETC security and the secondary market price of the ETC securities can go down as well as up throughout the term of the ETC securities.

Intended Retail Investor: The ETC securities are intended for retail investors who (i) wish to gain FX-hedged exposure to silver without having to take physical delivery of silver; and (ii) are willing to hold a long term investment and can afford to risk losing their investment.

Product term: This series of ETC securities has a scheduled maturity date of 15 May 2080. The scheduled maturity date may be postponed by up to ten business days on which a disruption event has not occurred. If this is the case we will provide you with notice of this and how many days such postponement will be. The ETC securities may be redeemed prior to the scheduled maturity date for certain reasons, including if: (1) we redeem all of the ETC securities in the series following thirty days calendar written notice to you; (2) an event of default occurs; or (3) an early redemption event occurs. A detailed description of events of default and early redemption events can be found in the prospectus in the Master Terms and Conditions of the ETC Securities.

What are the risks & what could I get in return?





The risk indicator assumes you keep the product for 7 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell or end your product easily or you may have to sell or end at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the secondhighest risk class. This rates the potential losses from future performance at a high level and poor market conditions are very likely to impact our capacity to pay you. Be aware of currency risk. If you receive payments in a currency different to that of your home jurisdiction, the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the risk indicator shown. Currency hedging may not be perfect.

You may lose some or all of your investment.

The risk category shown is not guaranteed and may shift over time. The lowest category does not mean risk free.

The ETC security value depends on the underlying metal price reacting to economic factors and it could fall for long periods.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

What happens if Xtrackers ETC plc is unable to pay out?

If we fail to make a payment when due, the trustee (Wilmington Trust SP Services (Dublin) Limited) can enforce the security over the silver deposited with the custodian. Once the trustee has enforced the security it can then sell the silver and use of the proceeds of this sale to pay amount owed to you under the ETC securities. The proceeds of such sale may not be enough to cover all amounts owed to you under the ETC securities. The product is a debt instrument and as such is not covered by any deposit protection scheme.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest €10,000.00. The figures are estimates and may change in the future.
