Objectives and investment policy

The fund is passively managed. The aim is for your investment to reflect the performance of the MSCI EFM AFRICA TOP 50 CAPPED TRN Index (index) which is designed to reflect the performance of the listed shares of 50 companies from African emerging and frontier market countries, as classified by MSCI Inc. (MSCI). The companies making up the index are large and medium sized companies. A company's weighting on the index depends on its relative size and only the 50 largest companies are included based on the combined value of a company's readily available shares as compared to other companies. The index is weighted and rebalanced in accordance with the MSCI 10/40 index Methodology (Methodology). The Methodology complies with legal requirements that the weight of a single issuer cannot exceed 10% of a fund's assets and the sum of the weights of all issuers representing more

than 5% of the fund's assets cannot exceed 40%. The Methodology applies a buffer by providing that the shares of one company cannot exceed 9% of the index and the shares of all companies representing more than 4.5% of the index cannot together exceed 36% of the index. The index is calculated on a total return net basis which means that all dividends and distributions are reinvested in the index after tax. The index is reviewed and rebalanced at least quarterly. To achieve the aim, the fund will enter into financial contracts (derivatives) with one or more swap counterparties to swap most subscription proceeds for the return on the index. The currency of the fund is USD. Returns and gains are not distributed but are reinvested in the fund. You may request the redemption of shares generally on a daily basis.

Risk and reward profile

The calculation of the risk and reward profile is based on historical data that cannot be used as a reliable indicator for the future risk profile. This risk indicator is subject to changes; the classification of the fund may change over time and cannot be guaranteed. Even a fund that is classified in the lowest category (category 1) does not represent a completely risk-free investment. The fund is classified in category 6 because its share price may fluctuate strongly and the likelihood of both losses and gains may therefore be high. The following risks could be of particular significance for the fund: The fund does not invest directly in the components of the index and its returns will be dependent on the performance of the derivatives used. The fund may enter into one or more derivatives with one or more counterparties. If any of the counterparties fails to make payments (for example, it becomes insolvent) this may result in

your investment suffering a loss. DWS entities and related companies may act in several roles in relation to the fund such as distributor and management company which may involve conflicts of interest. The fund is not guaranteed and your investment is at risk. The value of your investment may go down as well as up. The fund is exposed to less economically developed economies (known as emerging markets) which involve greater risks than well developed economies. Political unrest and economic downturn may be more likely and will affect the value of your investment. The fund is exposed to frontier / pre-emerging markets which involve much greater risks than investing in well-developed economies or even emerging markets. Political unrest, the lack of government regulation, economic downturn and limited liquidity may be much more likely and could therefore affect the value of your investment. The derivative used to gain exposure to the index may be adjusted to reflect certain expenses in relation to taxes and/or buying, selling, borrowing, financing or custody costs. Charges

The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

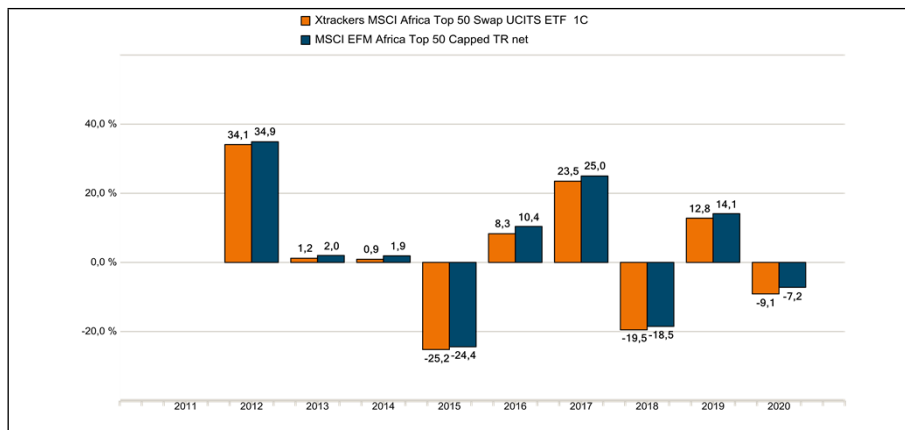
