What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Natural Gas 1x Daily Short is a fully collateralised Exchange-Traded Commodity (ETC) designed to provide investors with a short exposure to Natural Gas. The ETC provides a total return comprised of -1 times the daily performance of the Bloomberg Natural Gas SL Excess Return Index (BNGSLER), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Natural Gas SL Excess Return Index rises by 1% over a day, then the ETC will fall by 1%, excluding fees. However if the Bloomberg Natural Gas SL Excess Return Index falls by 1% over a day, then the ETC will rise by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product.
