

## Key Information Document for U.S. Global Jets UCITS ETF (the **Fund**), a sub-fund of HANetf ICAV Class - Accumulating

### What is this Fund?

<b>Type</b>	<p>The Fund is a sub-fund of HANetf ICAV (the <b>ICAV</b>), an open-ended Irish collective asset-management vehicle umbrella fund with segregated liability between sub-funds, with variable capital established under the laws of Ireland and authorised by the Central Bank under the UCITS Regulation 2011, as amended.</p> <p>The Fund seeks to track the price and yield performance, before fees and expenses, of the U.S. Global Jets Index (the <b>Index</b>). The Index is governed by a published, rules-based methodology and is designed to measure the performance of global investable universe of publicly listed companies of passenger airlines, aircraft manufacturers, airports and terminal service companies and airline related internet media and services companies across the globe (the <b>Airline Companies</b>).</p> <p>To be eligible for inclusion in the Index, companies must:</p> <ul style="list-style-type: none"> <li>• have, or expected to have, exposure to Airline Companies;</li> <li>• meet the minimum market capitalisation and liquidity requirements; and</li> <li>• not have common stock which is listed on a securities exchange in a country that does not allow the transfer of securities "free of payment" (e.g., Brazil, China, India, Russia, South Korea, Taiwan).</li> </ul>
<b>Objectives and Policies</b>	<p>The Index is rebalanced quarterly in March, June, September and December. At the time of each rebalance, companies are ranked and tiered. The constituents fall into 5 tiers (the <b>Tiers</b>) which are then ranked by factors. Tiers 1 and 2 are ranked by market capitalisation, average dollar value traded and passenger load factor. For Tiers 3 to 5, six factors are used to determine a constituents ranking (namely, market capitalization, average dollar value traded, cash-flow return on invested capital, sales per share growth, gross margin, and trailing 12-month sales yield). Tiers 1 to 3 make up 80% of the Index and contain 20 US and Canadian companies. Tiers 4 and 5 make up 20% of the Index and contain 20 international companies. Tiers 1 to 2 are both ranked by market capitalisation, average dollar value traded and passenger load factor.</p> <p>The Fund will employ a "passive management" (or indexing) investment strategy and will seek to employ a replication methodology, meaning as far as possible and practicable, it will invest in the securities in proportion to the weightings comprising the Index.</p>

<b>Additional Information</b>	<p>Shares of the Fund are listed on one or more stock exchanges. Typically, only authorised participants (i.e., brokers) can purchase Shares from or sell Shares back to the Fund. Other investors can purchase and sell shares on exchange on each day the relevant stock exchange is open.</p> <p>Income received by the Fund's investments will not be distributed in respect of the shares of this class. <b>Term</b>	The fund has no minimum fixed term, although the recommended holding period is 5 years. Termination of the Fund is only possible in those cases expressly provided for in the Prospectus or Supplement of the Fund.
<b>Intended retail investor</b>	The Fund is intended to be offered to retail investors who are seeking capital growth over the long term. An investment should only be made by those persons who are able to sustain a loss on their investment. Typical investors in the Fund are expected to be investors who want to take exposure to the markets covered by the Fund's investment policy and are prepared to accept the risks associated with an investment of this type, including the volatility of such market.

## What are the risks and what could I get in return?

### Summary Risk Indicator



The risk indicator assumes you keep the Fund for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this Fund compared to other Funds. It shows how likely it is that the Fund will lose money because of movements in the markets or because we are not able to pay you. We have classified this Fund as 6 out of 7, which is a high-risk class.

This classification takes into consideration two elements:

1) the market risk - that rates the potential losses from future performance at a high level; and 2) the credit risk which estimates that poor market conditions are very unlikely to impact our capacity to pay you.

**Be aware of currency risk. The Fund invests in securities denominated in currencies other than its base currency. Changes in the exchange rates may adversely affect the performance of the Fund. This risk is not considered in the indicator shown above.**

The Fund does not include any protection from future market performance so you could lose some or all of your investment. Investment by the Fund in other collective investment schemes, emerging markets and use of derivatives may involve additional risks. ### Performance Scenarios

### What happens if the HANetf Management Limited is unable to pay out?

HANetf Management Limited, as PRIIPS manufacturer of the Fund, is not obliged to make any payment in relation to the Fund, such obligations being those of the Fund itself. The assets of the Fund are kept separately from those of the Manager. An insolvency or default of the Manager should not result in the Fund suffering any financial loss in relation to its assets. The amount the Fund is obliged to pay out is linked to the net assets of the Fund so it is unlikely that the Fund will be unable to pay out unless there is an operational error or an insolvency or default by the Depositary which holds the Fund's assets on its behalf. In the event of the insolvency or default of the Depositary, securities held by the depositary on behalf of the Fund should be protected but the Fund may suffer loss in relation to cash and certain other assets which are not protected. Investment in the Fund is not covered by any investor protection scheme."

### What are the Costs?

The party advising on or selling you this Fund may charge you other costs. If so, this party will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover one-off, ongoing and incidental costs. ## How long should I hold the Fund and can I take my money out early?

The Fund has no required minimum holding period but is designed for longer-term investment, though it is recommended that you stay invested for at least 5 years. Investors are able to sell their investment on any day on which banks are open in the UK. When you cash in or if you switch between sub-funds, there may be a delay of up to 5 days for this Fund. By selling the Fund earlier than the recommended holding period, you may receive back less than you would have received if you had stayed invested until maturity. A redemption or exchange fee of up to 3% may be payable to the Manager in such circumstances, as well as any fees that may be charged by your broker.

You can make regular and one-off withdrawals. Withdrawals could be greater than any growth achieved and could reduce your investment's value below the amount invested. You should refer to the Prospectus and Supplement for this Fund for the conditions that apply and information on tax.
