# What is this product?

**Type:** Shares of a Sub-Fund of Lyxor Index Fund, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

**Term:** The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: This Sub-Fund is passively managed.

The objective of this Sub-Fund is to track the performance of STOXX Europe 600 Energy ESG+ Index (the "Index"),and to minimize the tracking error between the net asset value of the Sub-Fund and the performance of the Index. The Sub-Fund aims to achieve a level of tracking error of the Sub-Fund and its index that will not normally exceed 1%.

STOXX Europe 600 Energy ESG+ index (the "Index") is an equity index that tracks the performance of the companies of the STOXX Europe 600 (which represents the 600 leading securities of European developed countries) belonging to the ICB Energy Industry after a set of compliance, involvement and ESG performance screens are applied.

More information about the composition of the Index and its operating rules are available in the prospectus and at: <a href="www.stoxx.com">www.stoxx.com</a>. The Index value is available via Bloomberg (SXREESGP).

The exposure to the Index will be achieved through a direct replication, mainly by making direct investments in transferable securities and/or other eligible assets representing the Index constituents in a proportion extremely close to their proportion in the index.

The Investment Manager will be able to use derivatives in order to deal with inflows and outflows and which relate to the Index or constituents of the Index for investment and/or efficient portfolio management.

**Intended Retail Investor:** This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds and who are prepared to take on a high level of risk to their original capital.

Redemption and Dealing: The Sub-Fund's shares are listed and traded on one or more stock exchanges. In normal circumstances, you may deal in shares during the trading hours of the stock exchanges. Only authorised participants (e.g., selected financial institutions) may deal in shares directly with the Sub-Fund on the primary market. Further details are provided in the Lyxor Index Fund prospectus.

**Distribution policy:** As this is a non-distributing share class, investment income is reinvested. the accumulation share automatically retains, and reinvests, all attributable income within the Sub-Fund; thereby accumulating value in the price of the accumulation shares.

## What are the risks and what could I get in return?

### What are the costs?

Order schedule: Orders to redeem shares must be received before 04:00 PM Luxembourg time on the Valuation Day. Please refer to the Lyxor Index Fund Prospectus for further details regarding redemptions.
